# Nanchang University ECON31: Monetary Economics

(Last Updated in Jan. 2025)

Credit: 4

#### **Contact Hours**

This course is composed of 24 lecture sessions, 3 tutorial sessions and 9 office contact hours. Each lecture session takes 2 contact hours in length; each tutorial session takes 3 contact hours in length; There will be a Q-A review session (3 contact hours) and Final Exam (3 contact hours) at the end of this term. This course has 72 contact hours in total.

## **Course Description**

This course examines the link between money and economics activity in more detail and the students will be guided to study various (traditional and more recent) views concerning the channel through which monetary policy can influence economic activity and take a look at the empirical evidence to date. In addition, students will study the role of institutions in explaining the behaviors of central banks and, thus economic activity. An emphasis on the current policy issues, and the current economic events and how they affect financial markets and monetary policy will also be discussed.

By taking this course, students will:

- 1. Learn the fundamentals of the financial and monetary system;
- 2. Understand how economic news affects financial markets;
- 3. Understand how to think analytically, using economic theory to solve problems;
- 4. Study several topics in greater depth than provided by the textbook.
